ProVia Replacement Window Tax Credit Certification

This manufacturer's certification statement is for product purchased and installed on or after **June 1, 2009 through December 31, 2010**.

This manufacturer's certification statement provides the documentation needed to receive an energy tax credit for ProVia Replacement Windows as defined by IRS Notice IR-2009-44 Section 1142 (dated 04-22-09) and the *American Recovery and Reinvestment Act of 2009*. How to Qualify for the 2009 - 2010 Tax Credit:

1. Purchase and install qualifying products beginning June 1, 2009 through December 31, 2010. Tax credit is for cost of product only - it does not include installation costs. Tax credit is for taxpayer's principal residence only.
2. Must have this Manufacturer's Certification Statement to qualify - it is a signed statement from us certifying that the product or component listed qualifies for 2009-2010 tax credits. Taxpayer must keep a copy of this certification statement or Energy Star label and purchase receipts for their records, but do not have to submit a copy with their tax return.
3. Tax credit is 30% of product cost or a maximum amount of \$1,500.00 over a two year period for 2009 and 2010.
4. Improvements made in 2009 will be claimed on your 2009 taxes (filed by April 15, 2010) using the IRS Tax Form 5695 (2009 version).

Please Note: All qualifying models and glass styles are listed as of May 22, 2009. Due to ongoing product changes and revisions of industry standards and requirements, this information will be updated periodically to reflect those revisions.

Manufacturer's Certification Statement
